Assoc. Prof. Dr. Nguyen Thi Lan Anh is the Vice President of the Diplomatic Academy of Viet Nam (DAV) and concurrently serves as Dean of the International Law Faculty at DAV. She is also the Vice President of the Asian Society of International Law and an arbitrator nominated by Viet Nam under Annex VII of the 1982 United Nations Convention on the Law of the Sea (UNCLOS).

With over two decades of experience in international law, especially the law of the sea, Dr. Nguyen has held various academic and diplomatic positions, including Minister Counsellor at the Embassy of Viet Nam in the United Kingdom (2018–2021). Her work focuses on maritime security, international dispute settlement, and regional legal cooperation.

She serves as a legal adviser to several expert groups within the Ministry of Foreign Affairs and contributes to Vietnam's legal engagement in multilateral settings, including its term as a non-permanent member of the UN Security Council (2020–2021).

Dr. Nguyen has published extensively on issues of international and maritime law with leading academic publishers and journals. She also lectures internationally in training programs for government, military, and legal professionals across the Asia-Pacific and beyond.
